#### Billboard rental: Terms and Conditions

1. The RENTER shall keep and maintain the rented equipment in a good state, free from damage.
2. The RENTER shall reimburse the OWNER ([humanbillboard.com.au](http://humanbillboard.com.au)/Für Jedermann Pty Ltd) for any damage, theft or loss required to bring the billboard/s back to the same condition they were at the time of rental (No screen cracks, chips or heavy scratching AND no heavy denting or warping of frame AND no electrical faults).

The RENTER agrees to compensate the OWNER the following prices in the event of such damage mentioned above

- Up to \$593.00 + GST per billboard or electrical fault replacement PER BILLBOARD
- \$170.00 + GST per acrylic screen PER BILLBOARD

3. \$50 deposit per board is required for all billboard hires that is refunded at the end of hire, unless any damage in relation to clause 2 is required, in which case the RENTER shall forfeit their deposit.
4. The equipment shall be delivered to RENTER and returned to OWNER at the RENTER's risk, cost and expense. If the equipment is not returned during or at the end of the term, unless otherwise agreed upon, then the rental charges shall continue at \$64.00 PER BOARD / PER DAY
5. No allowance will be made for any rented equipment or portion thereof which is claimed not to have been used. Acceptance of returned equipment by OWNER does not constitute a waiver of any of the rights OWNER has under the rental agreement.
6. The RENTER shall allow the OWNER to enter RENTER's premises where the rented equipment is stored or used at all reasonable times to locate and inspect the state and condition of the rented equipment. If the RENTER is in default of any of the terms and conditions of this agreement, the OWNER, and his agents, at the RENTER's risk, cost and expense may at any time enter the RENTER's premises where the rented equipment is stored or used at all time and recover the rented equipment.
7. The RENTER shall not pledge or encumber the collection of rented equipment in any way.
8. The OWNER may terminate this agreement immediately upon the failure of RENTER to make rental payments when due, or upon RENTER's filing for protection from creditors in any court of competent jurisdiction.
9. The OWNER makes no warranty of any kind regarding the rented equipment, except that the OWNER shall replace the equipment with identical or similar equipment if the equipment fails to operate in accordance with the manufacturer's specifications and operation instructions. Such replacement shall be made as soon as practicable after RENTER returns the non-conforming equipment.

10. Any damage caused to Artwork/Posters shall not be replaced or repaired by OWNER.
11. The RENTER indemnifies and holds OWNER harmless and NOT RESPONSIBLE for any and all injuries, fines, required permits and damages of any kind whist the billboard/s are within RENTERS care (until OWNERS pickup), Including but not limited to, physical damage to pedestrians or billboard walkers, shop facades or any structures.
12. The RENTER shall pay all reasonable attorney and other fees, expenses and costs incurred by the OWNER in protection of its rights under this rental agreement (terms and conidtions) as well as any action taken by the OWNER to collect any amounts due the OWNER under this rental agreement.
- All terms and conditions (marked in pages 1 and 2) have been read and are accepted by the RENTER, agent or other representative, and are acknowledged and understood upon delivery of the billboards and/or by signature below. The RENTER, Agent or other representative accepts that any breach of contract, inclusive of that requireing compensation to OWNER shall be charged to credit card details supplied.
